National Crime Information Center (NCIC)



- 21 files (14 persons and 7 property)
- 12.7 million records
- Average 12 million transactions daily at less than 0.02 seconds
- Interstate Identification Index (III) contains automated criminal history record information
 - Accessible through the same network as NCIC

NCIC Access Requirements



- Criminal Justice Agencies performing the administration of criminal justice functions
- Originating Agency Identifier (ORI) Number

Biometric Identification and the Next Generation Identification (NGI)

• State-of-the-art biometric identification services including fingerprints and compiles core capabilities that serve as the platform for multimodal functionality

NGI Access Requirements

- Authorized access to FBI criminal history record information for civil purposes only after the establishment of positive identification through fingerprint processing (42 USC 14616)
- Federal or state statute (approved by the FBI under PL 92-544) must exist that authorizes a national background check

- FBI-approved Channeler
 - Civil submissions only
- Hard Copy
 - Mailed to CJIS Division

Criminal Access

• 28 USC 534 and 28 CFR 20.33 (a)(1)

Civil/Applicant Access

- Tribal Childcare Pub. L. 101-630 (25 USC 3205, 3207)
- Housing Pub. L. 104-330 (25 USC 4138)
- Gaming Pub. L. 100-497 (25 USC 2701)
- National Racing Compact 28 USC 534 note
- Also, numerous state statutes include tribal entities for state and/or national civil background checks

BIA Purpose Code X

 Approved by the National Crime Prevention and Privacy Compact Council in May 2015



- Enables III Name-based access with delayed submissions of fingerprints in emergency child placement situations
- Authority: Public Law 101-630
- BIA and FBI worked together on implementation procedures
- Eastern Band of Cherokee (NC) first tribe to participate in Purpose Code X with BIA

National Data Exchange (N-DEx)



- Provides criminal justice agencies with a mechanism for sharing, searching, linking, and analyzing information across jurisdictional boundaries.
- Contains records from the entire criminal justice lifecycle such as incidents, arrests, pre-trial, supervised releases, and incarcerations.
- Provides access to more than 5,000+ agencies
- Connects regional and local information sharing systems

N-DEx Access Requirements



- Criminal Justice Agencies or agencies performing the administration of criminal justice
- Active ORI
- Approval required

National Instant Criminal Background Check System (NICS)



- Developed in response to Brady Handgun Violence Prevention Act of 1993
- Screen potential firearms buyers
- Permits and disposition of firearms background checks

Federal Firearm Prohibitions



The federal firearm prohibitions apply to any person who:

- (g)(1)Has been convicted of a crime punishable by imprisonment for a term exceeding one year (or a misdemeanor crime punishable by imprisonment over two years)
- (g)(2) Is a fugitive from justice
- (g)(3) Is an unlawful user of or addicted to any controlled substance
- (g)(4)Has been adjudicated as a mental defective or committed to a mental institution
- (g)(5)Is an alien and is illegally or unlawfully in the United States
- (g)(6)Has been discharged from the Armed Forces under dishonorable conditions
- (g)(7)Has renounced their U.S. citizenship
- (g)(8)Is subject to a qualifying protection/restraining order
- (g)(9)Has been convicted in any court of a misdemeanor crime of domestic violence
- (n) Is under indictment/information for a crime punishable by imprisonment for a term exceeding one year

LEEP Access Requirements



- Affiliated with the criminal justice system, intelligence communities, military personnel and governmental agencies associated with infrastructure protection of the United States.
- Other individuals will be considered on a case by case basis as determined by their role in offering direct support to the Criminal Justice System.

TAP Access to CJIS Systems

- DOJ serves as the CJIS Systems Agency for Federally Recognized Tribes
 - Grant network access
 - Ensures personnel, IT, and physical security
 - Vetting and on-boarding
 - Testing
 - Training
 - Auditing

TAP Access to CJIS Systems

- DOJ provides integrated workstations
 - Computer
 - Palm and fingerprint scanner
 - Camera
 - Flatbed scanner
 - Printer

{Allows the agency to access and enter data into national crime information systems}

TAP Access to CJIS Systems

- DOJ provides enhanced training and assistance
 - Online
 - In person
 - Assists tribes in analyzing needs
 - Identify/provide appropriate solutions
